### Rules & Information Sheet

1. The DEADLINE for entries is **Friday April 30, 2010**. Entries must be turned into the Fair Office no later than 5:00 p.m. on Friday. The "Youth Steer Saddling" will be held Monday, May 3<sup>rd</sup> in conjunction with Family Fun Night at 7:00 p.m.
2. Entry forms will not be accepted without CONTESTANT WAIVER AND RELEASE FORM.
3. Each contestant must be 14 to 18 years of age as of May 3, 2010.
4. Each team consists of three (3) members.
5. **If a Liability Release is not on fill in the fair office for each contestant that team will be disqualified.**
6. One team member must ride the steer over the finish line. The head rope must be off the steer before the steer crosses the line for a time.
